

**OFFICIAL RULES
ATA Benefit Sweepstakes**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. OPEN ONLY TO LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES OR DISTRICT OF COLUMBIA. VOID WHERE PROHIBITED. Employees, and their immediate families (parent, child, spouse or sibling and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, of Amateur Trapshooting Association (“Sponsor”), The Event Group (“Administrator”), and their respective parents, affiliates, subsidiaries, advertising and promotion agencies and website providers/web masters are not eligible to enter or win. TO ENTER: Between December 7, 2007 and August 15, 2008 (“Entry Period”), there are two (2) ways to enter: 1) purchase a ticket for \$5 at any participating gun club, SCTP group, state association or individuals, while supplies last, and you will be automatically entered into the drawing. Multiple tickets may be purchased. All proceeds will go to benefit the Amateur Trapshooting Association. Or 2) to enter without purchase, hand-print your name, complete address, day and evening telephone numbers (including area code) and date of birth, and if a minor, your parent’s or legal guardian’s signature. on a 3” x 5” card and mail it in an envelope with first class postage affixed to: ATA Benefit Sweepstakes, 601 West National Road, Vandalia, OH 45377. Mail-in entries must be postmarked by August 8, 2008 and received by August 15, 2008. Entries must be handwritten. Entries that have been mechanically reproduced are void. Enter as many times as you wish, but each entry must be mailed separately. All entries become the property of Sponsor and will not be returned.

WINNER SELECTION: Potential winners will be selected in a random drawing scheduled to take place at the Grand American on August 15, 2008 from all eligible entries received. Odds of winning depend on the number of eligible entries received for the drawing at issue. You need not be present to win. Potential winners will be announced at the Grand American and notified by telephone, phone and/or email and may be required to execute and return an affidavit of eligibility, a liability release and where lawful a publicity release within seven (7) days of date of issuance.
